## CONGRESSIONALLY DIRECTED SPENDING 2021-2026

Senator Susan Collins serves as Chair of the Senate Appropriations Committee. The Committee holds jurisdiction over all discretionary spending for the entire federal government.

First elected in 1996, Susan Collins ranks seventh in Senate seniority and is the most senior Republican woman. She is the first Republican woman to be elected to a fifth term, the first Republican woman to Chair the Senate Appropriations Committee, and the first Mainer to Chair the Committee in 92 years.

As Chair, Senator Collins champions investments in Maine that promote job creation and economic development, improve infrastructure, enhance the wellbeing of Mainers, and protect our environment.

The Congressionally Directed Spending (CDS) process is an opportunity for Senator Collins to advocate for federal funding for specific projects in Maine. This opportunity is available to nonprofit entities and state and local governments. For-profit entities are not eligible for CDS funding.

Since 2021 alone, Senator Collins has secured nearly \$1.5 billion for communities in all 16 counties across Maine. From fire departments and public safety resources, to roads and bridges, to hospitals and cutting-edge research at the University of Maine, to child care programs and community centers, these federal investments have helped strengthen towns and communities across Maine.
